M/s Rathi Graphic Technologies Limited (the Company) was undergoing Corporate Insolvency Resolution Process ("CIRP") and subsequently the resolution plan ("Resolution Plan") submitted by M/s Surbhika Steels Private Limited through its unit Nikunj Udyog ("Successful Resolution Applicant") was approved by the Honble National Company Law Tribunal, Allahabad Bench (NCLT) vide its order dated 27th July 2023, read with Honble NCLAT order dated 15.10.2024. As per the terms of the approved Resolution Plan, a monitoring committee ("Monitoring Committee") was constituted, to oversee the implementation of the resolution plan. After settling all the claims as per the Approved Resolution Plan, the Monitoring Committee in its meeting held on 7th February, 2025 reconstituted the Board of Directors of the Company with all the new directors dissolving the then existing Board of Directors in terms of the approved resolution plan by Hon'ble NCLT, Allahabad Bench and further handed over the control of the affairs of the Company to the new management of the Company effective from 7th February, 2025. No Committee meeting was held during first quarter of FY 2025-26.
